Habitat for Humanity of Greater Greensboro uses HUD guidelines to determine your household income when reviewing your Application for Homeownership. However, to determine eligibility to participate in our Homebuyer Education Program, please complete a household income form. Return form with your application.

- **1. Select the total number of people in your household.** Be sure to include all children and adults, related and unrelated, that live in a single dwelling and share income and expenses.
- 2. Select the box that represents the range of annual household income. Make sure to include all of the following income sources: work, welfare, child support, alimony, pensions, retirement, Social Security, SSI, VA benefits, child income and/or all other income. The amount should be <u>before</u> any deductions for taxes, insurance, medical expenses, child support, etc. **Child support and alimony are optional.**
